Introduction

Lps Bilişim Hizmetleri Ticaret A.Ş., the company behind LpsChain (<https://lpschain.com/>), in the following also referred to as "we" or "us", respects your privacy and recognizes the importance of protecting the confidential information stored on our servers, on our network or intended to be stored on our network. As a user of our Service, this Privacy Policy informs you about the way we work to ensure the privacy and confidentiality of personal information and explains how we use the information we collect. By using the Service, you agree to the collection and use of information in accordance with this Privacy Policy. This Privacy Policy applies only to information we collect through the website and does not apply to information we may collect from other sources. Please read this privacy policy carefully. By visiting this website, you accept the practices described in this privacy policy.

You can access LpsChain by registering via the <https://www.lpschain.com> (in the following also referred to as "Website"), by the LpsChain mobile application, or by other means that we might specify if future changes to this Privacy Policy. Please check the website for the latest changes to the Privacy Policy. LpsChain is a blockchain-based system for data management, such as storage, shared access, data modification, and deletion. Uploaded data files are stored and backed up in encrypted pieces. The purpose of LpsChain is to manage the data uploaded by registered users according to the data owner's purposes, such as data storage for a specified or unspecified period, granting access to other registered users as specified by the data owner, data modification by other registered users as specified by the data owner, data delete by the data owner. LpsChain does not use or access data content on its own, or grant access to unauthorized parties.

Personal Information That We Collect

When you use our Website, Lps Bilişim Hizmetleri Ticaret A.Ş. may collect personal information about you. The amount and type of information that Lps Bilişim Hizmetleri Ticaret A.Ş. collects depend on the nature of the interaction. These are explained in the following bullet points (in the following collectively referred to as "Personal Data"):

Personal information that you voluntarily provide:

- Data to access our Service via the website (your name, your date of birth, your e-mail address, any other information needed to process your questions or problems);
- All personal information you send to Lps Bilişim Hizmetleri Ticaret A.Ş. via e-mail.

Personal information we may collect automatically when you use the Website, specifically data from your device. This data can be considered personal information in accordance with applicable data protection laws. The information that we may automatically collect comprise (see also next section "Cookies"):

- Data related to and for the purpose of analysis of your use of our Website;
- Your IP address and device identifiers;

- Your device type and the operating system you use;
- Broad geographical location based on your IP address.

Cookies

Cookies are files containing small amounts of data, which may include an anonymous unique identifier. The Website sends cookies to your browser, which are stored in your device's memory. Lps Bilişim Hizmetleri Ticaret A.Ş. may use cookies, similar technologies, and services for the purpose of collecting information. You may set your browser to deny all cookies or to prompt you when a cookie is being sent. However, if you don't receive cookies, you may not be able to access and use certain sections of our Website. Our Website may use cookies and other technology, including pixel tags, scripts, and web beacons. This technology provides a better understanding of your behavior and indicates which parts of our Website you've visited. Information collected through cookies and other technology is considered non-personal information. However, in cases when IP addresses or other related identifiers are considered personal information by local legislation, Lps Bilişim Hizmetleri Ticaret A.Ş. also considers these identifiers as personal information. Similarly, with regard to non-personal information and data stored or used in conjunction with personal information, Lps Bilişim Hizmetleri Ticaret A.Ş. considers this joint information as personal information guarded by this Privacy Policy. We may, at our sole discretion, gather certain data automatically, and hold it in log files. This information may include IP addresses, browser version, internet provider, operating system, language, date/time stamp, and/or other information. We may use this information to pinpoint trends, monitor your behavior on the Website, administer the Website, improve our services, collect demographic information on our users for general and marketing/advertising purposes.

Security of Your Personal Data

We know that the security of your information is very important and that it requires strong administrative, technical, and physical security checks to ensure that your data is safe and secure. Our privacy practices are designed to provide protection for your personal information worldwide. Your Personal Data comes to us over the internet, which chooses its own routes and vehicles and where information is transmitted from one place to another. We regularly check our procedures and security measures to ensure that they are properly managed and remain effective and appropriate. Each member of Lps Bilişim Hizmetleri Ticaret A.Ş. is bound by our privacy policies and procedures to protect your Personal Data. Our Website has security measures to protect against the loss, misuse, and unauthorized alteration of the information under our control. Lps Bilişim Hizmetleri Ticaret A.Ş. retains your information as needed to provide you with website content and services. If the storage of personal information is foreseen by law, it is targeted to keep this information for as long as necessary. Lps Bilişim Hizmetleri Ticaret A.Ş. has implemented appropriate technical and institutional measures to protect the confidentiality and integrity of your information and to prevent unauthorized access and use of information in violation of this Privacy Policy. Please note that while we make reasonable efforts to keep your information safe, there is no absolute guarantee that the applied security measures cannot be overcome.

Retention and Erasure of Your Personal Data

Lps Bilişim Hizmetleri Ticaret A.Ş. will retain your Personal Data only as long as it is necessary for the purposes set out in this Privacy Policy. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies. The company will also retain usage data for internal analysis purposes. Usage Data is generally retained for a shorter period, except when this data is needed to strengthen the security or to improve the functionality of our service, or we are legally obligated to retain this data for longer time periods. You can obtain from us to delete or remove your Personal Data under certain circumstances, as long as we no longer have a legal or regulatory obligation to retain it.
